Central Park Multi-Purpose Center Improvements

Page 2, 1a, provide the title and detailed description of the public infrastructure improvements

The existing Central Park Multi-Purpose Center houses the City of Plantation's Parks & Recreation Department administrative staff, an exercise room, game room, single basketball court/gymnasium, general purpose locker rooms, office space for aquatics program staff, several classrooms, storage rooms and restroom facilities. The existing building cannot meet the current programs and staffing needs. Noise from daily activities in the building impacts administrative staff offices which makes it very difficult for staff to work effectively. The existing building layout and access to the building does not permit a most efficient operation for programs in the building or the aquatics program. Planned expansion of programs will only worsen these conditions.

The City of Plantation has conceptualized a project to perform selective demolition of the existing building down to its shell and re-design the interior with a new space plan to meet current and future needs. In order to maximize this approach, the City of Plantation has conceptualized the construction of a prefabricated steel 2-court gymnasium building to be located adjacent to and south of the existing building. Independent vehicular access for the aquatics program and other programs is envisioned to assist with program efficiency. Temporary relocation of administrative staff to a modular building will be necessary.

Page 2, 1e, provide a detailed explanation of how the public infrastructure improvements will connect to a broader economic development vision for the community and benefit additional current or future businesses.

The City of Plantation hosts 83 events within its entire Parks and Recreation program. From these events hosted, 52,000 regional, national and international athletes participate and 150,000 spectators attend these events. The economic impact is \$29.5 million dollars to the local community. Central Park is located at the heart of Plantation and is host to a myriad of activities, including afterschool classes, youth sports programs, adult athletic leagues, fitness classes, special events, summer camps, athletic tournaments, swim meets and tennis tournaments.

Last year, the athletic activities held at Central Park hosted 7,000 participants and 24,000 spectators; aquatics events hosted 4,000 participants and 14,000 spectators and tennis events hosted 3,000 participants and 10,000 spectators. These events held at Central Park's facilities were responsible for a total of \$24.7 million in direct economic impact for the local economy. Therefore, once the renovations of the Central Park Multi-Purpose Center is complete, an increase of several thousand participants and spectators in attendance are expected. With improved infrastructure, the new facility will be more easily accessible by various sports teams and leagues, as well as create a more efficient use of the aquatics facility, increasing the ability to host larger national swim meets. The new, state-of-the-art facility will be an ideal location to serve the growing number of Plantation residents and host additional classes (including fitness, cultural arts and computer programs), sporting and community events. This increased programming will have a direct positive impact on 10 local hotels, 43 restaurants businesses in our community and a myriad of surrounding attractions. With additional participants, spectators and events, the City and the surrounding restaurants, hotels and other attractions within the region will potentially enjoy an increase of local community revenue of approximately \$2 million dollars.

Within walking distance from the Central Park Multi-Purpose Center and the Aquatics Center is the Frank Veltri Tennis Center. The Frank Veltri Tennis Center features 26 lighted clay tennis courts & 2 lighted hard courts. This facility hosts many world class events such as the Orange Bowl Tennis Tournament, the USTA Girls 14's National Tennis Tournament, the ITF International Junior Tennis events, Summer Tennis Camp and Pool programs, adult tennis leagues and a myriad of tennis classes available to the City's residents and non-residents. The tennis players and attendees will utilize the upgraded Central Park Multi-Purpose Center and Aquatic Center before, during and after their tennis events.

Along with South Florida's favorable year-round climate and central location in Broward County, Central Park is easily accessible to the millions of residents in Miami-Dade, Palm Beach and Broward Counties. Out of state and International travelers can easily access the park through Ft. Lauderdale-Hollywood International Airport and Miami International Airport.

The City of Plantation will, through its competitive procurement process, hire approximately 35 people for this project. The types of construction positions the City will hire will be design professionals, demolition and construction workers. The wages for this construction professionals will be vetted pursuant to the City's competitive procurement process and is unknown at this time.

The subject project is anticipated to require outside agency approvals/permits through the Old Plantation Water Control District for storm water management, Broward County for water/wastewater and the City of Plantation Building Department for Florida Building Code compliance.

Sec. 2-129. - Chief administrative officer.

The chief administrative officer is a senior executive of the city who serves under the general supervision and direction of the mayor. The Charter of Plantation provides that the mayor is the chief executive officer of the city. The chief administrative officer is the department head of the administration. The chief administrative officer does not occupy a municipal office; therefore, while the chief administrative officer has the general authority to supervise and direct other department heads in the exercise of their administrative functions and duties, the chief administrative officer does not possess or enjoy any sovereign law enforcement or life safety power of the city, and consequently cannot direct department heads vested with such power with respect to whether or the manner in which they choose to exercise or not exercise such power. The chief administrative officer has the specific authority to: negotiate and execute contracts, liability indemnifications, licenses, easements, deeds, notes, and satisfactions or releases of liens or claims or interests in real property; make administer, and perform legal undertakings, including effecting or approving purchases or payments; and make decisions binding on the city during various types of negotiations or legal proceedings. The chief administrative officer shall additionally perform such other duties and functions and tasks as may be directed by the mayor.
