### Public Infrastructure Grant Eligibility

Pursuant to section 288.101, F.S., the Florida Job Growth Grant Fund was created to promote economic opportunity by improving public infrastructure and enhancing workforce training. Eligible governmental entities that wish to access this grant fund must submit public infrastructure proposals that:

- Promote economic recovery in specific regions of the state, economic diversification or economic enhancement in a targeted industry. (View Florida's Targeted Industries here.)
- Are not for the exclusive benefit of any single company, corporation or business entity.
- Are for infrastructure that is owned by the public and is for public use or predominately benefits the public.

	Dixie Highway Marine Corridor Improvements - This is a wide area of Right of Way with the potential to accommodate on street parking in areas. The proposed changes are as follows: Create on street parking to provide an option for visitors to park and walk /cycle into Historic Downtown Stuart; Improve pedestrian flow with incorporation of street signage, street furniture and improved landscaping; Provide a clearly defined entrance point to Historic Downtown Stuart through signage and clever streetscaping; Encourage commercial and restaurant activity to expand out of Downtown Stuart to the northern
	area of the CRA, utilizing the proposed improved pedestrian links, proposed on street parking and the proposed more well defined link to the central areas of Stuart.
	The redesign of the North Dixie Highway corridor will contribute to the quality of life; serve the common good; contribute to a thriving and bustling downtown; adds to commercial diversity; and generates private sector interest.

Stuart is home to a \$227 million maritime economy that supports more than 5,000 jobs, Martin County FL is an ideal location for marine-based companies. Improving Dixie Highway Corridor will increase the areas role as a marine oriented center on lands east, west and immediately north of the bridge. Lastly, this improvement will entice investors and local businesses to continue to accommodate marinas, hotels and water-orientated development. Martin County has strong boat-building & related businesses; abundant water access and waterfront sites; affordable and experienced maritime workforce; specialized marine job training programs; and superior access to key maritime markets.

Based on the DEO Cluster Map of 2015, jobs relevant to the marine industry are just under 3% in Martin County. Most marine jobs range between \$48,000 and \$65,000.

The metrics used to measure a successful economic impact would be the number of jobs retained and created along this corridor. In addition, property values increase, increase in business permits due to the opening of new businesses along the corridor.
