

CDBG Second Public Hearing Notice Example

City of Hibernation, Florida Second Public Hearing Notice

The City of Hibernation plans to apply to the Florida Department of Economic Opportunity (DEO) for a FFY 2015 Small Cities Community Development Block Grant (CDBG) of \$650,000 in the Neighborhood Revitalization category. The activities, dollar amounts and estimated percentage benefit to low- and moderate-income persons are as follows:

Administration	\$50,000	NA
Engineering	\$37,000	NA
New Sewer Lines	\$350,000	60%
Sewer Hookups	\$33,000	100%
Street Paving	\$180,000	60%

The City will install approximately 2,000 linear feet of new sewer lines to serve homes on Oak, Pine and Dogwood streets. Sewer hookups will be provided for at least 16 low- and moderate-income households on the same three streets. Following sewer installation, Oak, Pine and Dogwood streets will be paved.

The City of Hibernation does not expect that anyone will be displaced as a result of CDBG-funded activities. If any persons are displaced as a result of the planned activities, the City of Hibernation will assist them as described in the City's anti-displacement and relocation policy, which is available for review at City Hall.

A public hearing to provide citizens an opportunity to comment on the application will be held at Hibernation City Hall, 123 Main Street, on February 9, 2016, at 6:00 p.m. A draft copy of the application will also be available for review during normal business hours in the Clerk's Office at City Hall by noon on February 5, 2016. Persons wanting to submit written comments on the application should send them to Joan Doe, city clerk, by e-mail at jdoe@hibernation.fl.ci or by mail to 123 Main Street, Hibernation, Florida 39999 no later than February 16, 2016.

A copy of the final application will be available for review in the Clerk's Office at City Hall no later than February 23, 2016. The application will be submitted to DEO on or before March 9, 2016.
