Employing agencies will work with DEO to determine eligible employees and distribute bonus payments. The minimum eligibility requirements a newly employed officer must meet to receive a bonus payment include:

- A person who gains or is appointed to full-time employment as a certified law
  enforcement officer with a Florida criminal justice agency on or after July 1, 2022, and
  has never previously been employed as a law enforcement officer in the state.
- Maintain continuous full-time employment with a Florida law enforcement agency for at least two consecutive years. The required two-year employment period at one or more Florida law enforcement agencies, but such a period must not contain any break longer than 15 calendar days.
