	Although the focus of extending wastewater collection lines is to facilitate economic development at the I-10/SR 59 interchange, the City-owned wastewater system will be available for area residents in this environmentally sensitive Wacissa Springs Basin which is considered an Impaired Outstanding Florida Spring.

	Based on the Business-Commercial Zoning at interchange I-10/SR 59, it will provide for numerous kinds of industry and commercial businesses to locate there which will create diverse employment opportunities for Jefferson County residents. There are currently approximately 13 businesses planning development on the north and south side of I-10 most of which will be located in a Federal Qualified Opportunity Zone funded by two existing Opportunity Funds, LP.

Florida Jobs Growth Grant Page 2. Section 1.-A: Detailed description of public infrastructure improvements.

The City of Monticello (City) proposes to construct a master lift station at the I-10/SR 59 interchange and construct a force main for approximately 11.8 miles to tie into the City's advanced wastewater treatment plant. The master lift station would serve all four (4) quadrants of the I-10/SR59 exchange. Local lift stations will be included along the route to facilitate additional tie-in by residential customers over time. Jefferson County authorized a route study, and the preferred route has been determined and is shown on Exhibit A which follows this narrative. The total cost for this project is estimated at \$5.96 million. A detailed cost estimate is included as Exhibit B which follows Exhibit A.

The City of Monticello has an Advanced Wastewater Treatment plant with a permitted capacity of 800,000 gallons per day. The current flow is 300,000 gallons per day. There is ample permitted capacity for growth in support of additional development at the I-10/SR 59 exchange which is currently served by an aging package plant using rapid infiltration basins in the southwest quadrant. The other quadrants have no wastewater infrastructure available. A major commercial developer recently purchased 449 acres of the northwest quadrant, which is a Federal Qualified Opportunity Zone, and is in the process of designing the acreage for mixed use commercial/light industrial and some residential. A second developer who has built an economy-level hotel in the southwest quadrant of the interchange, has reached capacity on the wastewater package plant that supports this hotel. He currently has plans to build a mega-Travel Center and a 100-room upscale hotel but cannot move forward without greater wastewater capacity.

The potential job creation and CAPEX investment impacts for the entire Interstate/Highway interchange are extremely significant to Jefferson County. The developers are planning for a minimum of 8-10 new businesses/companies in the targeted industries within 3-4 years generating an estimated \$32 million in CAPEX and a minimum of 450 new jobs. Using an average annual wage for manufacturing, logistics and last-mile distribution businesses (we have included relevant NAICS Codes), the developer's Administration office facilities alone estimates an ANNUAL employment impact of \$2,280,000 at startup based on a conservative average of \$57,000 and 40 jobs, and \$3,510,000 by year 3. The combined anticipated private investment (\$32m) from all the planned development projects plus the communities' (city and county) and public investment comes to a total of \$39,587,750. Given the requested FJGGF investment of \$5,960,000, the projected total ROI is anticipated to be extremely significant. Moreover, the critical job diversification and increase in the local tax base for the county would be extremely beneficial to all sectors of the population.

The proposed businesses and industries are consistent with Enterprise Florida and the State of Florida's Key Targeted Industries including Financial Investments (NAICS 523), Funds, Trusts and Other Financial Vehicles (NAICS 525), Transportation and Warehousing (NAICS 48-49), Miscellaneous Manufacturing (NAICS 339), Transportation and Warehousing (NAICS 48-49), Corporate Management of Companies and Enterprises (NAICS 55), and Administrative & Support Services (NAICS 611710) all within the Opportunity Zone northside of I-10. The planned businesses on the southwest quadrant of the I-10/SR 59

interchange include a 100-room nationally known chain hotel (NAICS 72110), and a Mega Travel Center (NAICS 447190; 445120; 722513).


The proposed public infrastructure expansion detailed in this grant application will provide a catalyst for economic development at an Interstate 10 interchange serving one of Florida's most economically challenged rural counties—Jefferson County. The proposed expansion of the City of Monticello's wastewater collection system (WW System) to this interchange will enable four quadrants of the interchange (Northeast, Northwest, Southeast and Southwest) to be served by the wastewater system, which has excess capacity, to recruit business and industry. The landowners have plans to both develop portions of their property and to market other portions of their property to other commercial developers, and as stated earlier the northwest quadrant is in a designated Federal Qualified Opportunity Zone. The sites/properties the wastewater collection lines will serve are all zoned "Interchange Business" of which all the industries would be allowed/consistent with this current zoning.


In addition to the economic development catalyst effect, the wastewater collection extension lines will provide a direct benefit to the environment and residents located along the 11.8-mile route. Old Lloyd Road is located within the Wacissa River Basin, which has been deemed an Impaired Outstanding Florida Spring (OFS) by the Florida Department of Environmental Protection (FDEP) due to substantial amounts of nitrogen loading into the groundwater system. Also, Old Lloyd Road is also located within the Wacissa Springs Group Basin Management Action Plan Area (BMAP) and is further identified as a Priority Focus Area (PFA) within the basin. A PFA is identified as the area most vulnerable to pollutants and where there is a known connectivity between groundwater pathways and an OFS. As part of the Wacissa BMAP, remediation of "Onsite Sewage Treatment and Disposal System" (OSTDS) is identified as one of the Springs restoration approaches. The construction of a centralized sewer system will allow many of the residents to discontinue use of septic tank systems, which will greatly contribute to the OSTDS remediation effort by eliminating a major source of nutrient loading to the Springs Basin. Once in place, the proposed sanitary sewer infrastructure will enable Jefferson County to utilize \$3,275,000 of its Restore Act 2021 Septic to Sewer Allocation to assist Lloyd area residents to move from septic tank to public sanitary sewer. If needed, this project is eligible for grant assistance through both the SRWMD and NWFWMD to aid to reduce nutrient loading into the Springs. Moreover, the current travel related commercial activities are currently being served through an aging "package plant" to service their sewer needs. The new wastewater infrastructure will enable more intensive water and sewer disposition uses through a highly robust sewer system. Water capacity and facilities are already in place through the Jefferson County Community Water System and can service the potable water capacity needs.

An important aspect to this proposal is the expressed support from both the City of Monticello and Jefferson County governments to move forward on this grant proposal. Also, the substantial investments that have already been made by the City, County and private interests (these are detailed later in the proposal) are significant. The fact that this wastewater collection expansion will address a critical gap in the shovel-readiness of the sites that were identified in the Strategic Sites Inventory (SSI) project and its analysis is specific documentation as to the prospective value of this investment. In addition, the public and environmental benefits to the project are extremely significant. We believe this project is ideally suited to fulfill the purpose and mission of the Florida Jobs Growth Grant program.

City of Monticello Wastewater Treatment Facility





Currently there an existing hotel supported by a wastewater package plant with very limited capacity. The owner has plans to build a new large 100-room hotel, a mega travel center containing 3 fast-food restaurants at the Lloyd exit and another developer is tentatively identified 7 projects to be located within the newly purchased Federally Qualified Opportunity Zone land which is also a state designated Opportunity Zone. The combined estimate of CAPEX is \$32 million and an estimated 538 jobs. Without the wastewater infrastructure, these economic development projects CANNOT move forward. It is easy to see the importance of the enhancement of utility services at the I-10 / SR 59 Interchange based on the public and private sectors investments already made. The city and the county have worked hard to develop the interchange to recruit business and industry to Jefferson County. However, until the Florida Jobs Growth Grant Fund's inception, all other grant programs require a written commitment by a company to create a minimum number of jobs to qualify for grant funds for infrastructure. The city has diligently applied for many grants which do not require job creation to accomplish as much of the preliminary feasibility studies and design and engineering as possible for the wastewater collection system improvements. The City and County desperately need funding from the FJGGF to bring economic development projects to diversify their economies.

It is very important to note Jefferson County has been *unable* to recruit a significant economic development project in the last 14 years. They have three interstate interchanges along I-10 of which two have no significant development. Once utilities were available at the I-10 / U.S. 19 interchange, it stimulated recruitment of three restaurants, three gas stations and several small businesses.

Please accept this letter of support for the City of Monticello's Florida Job Growth Grant Fund application for the Interstate 10/State Road 59 Interchange Infrastructure Improvements Project which will have a significant positive impact on the business holdings of Eshden Partners, LLC as well as many future commercial/light industrial developments. The funding request will be used to extend wastewater collection lines from the City of Monticello's recently constructed wastewater treatment plant to the interchange which has no public collection system. The collection lines will provide a public wastewater collection system in support of commercial, light industrial development as well as for residential users in an area filled with natural springs. Jefferson County is one of Florida's most economically challenged counties with limited areas to recruit light industry, commercial growth in hospitality, or logistic companies.

Eshden Partners, LLC, dba Eshden Company, has a longtime presence as a successful entrepreneur in Jefferson County and our utility services have grown as our company's footprint has expanded. Our hotel, restaurant and truck plaza are close to capacity for our wastewater package plant which has limited our ability to add additional businesses and services to existing and potential customers. We have plans to construct a nationally recognized chain 100-room hotel, a fast-food chain restaurant, a travel center, and other economically viable businesses. Our phase I development includes a \$ 12mllion construction of a state of the art travel plaza with 50 gas pumps and 50 EV charging stations. It will create 100 well paying jobs providing much needed economic boost to the area. However, without the City of Monticello constructing additional wastewater collection lines, the economic development plans cannot be implemented.

Please give every consideration to the I-10/SR 59 Interchange Infrastructure Improvement Project to provide greater wastewater collection capacity for business and industry at this underutilized interchange.

Dear Governor DeSantis,

Westchester Magnolia, LLC recently acquired properties in the Jefferson County Opportunity Zone located near the intersections of State Highway 59 and I-10. The entire acquisition included 172 acres in Western Jefferson County along with 277 acres in Eastern Leon County. In all honesty we purchased the Leon County parcel as a necessary condition of purchasing the Jefferson County Opportunity Zone parcels. While the Leon County property may serve to enhance economic activities of the Jefferson County property, it is the Jefferson County property that will be the focus of our business plan in that area.

Westchester Magnolia, LLC is a subsidiary of Greenwood Collection Opportunity Fund I, LP and Greenwood Collection Opportunity Fund II, LLC. Both Funds are Federal Qualified Opportunity Zone Funds. We purchased the properties to advance our Opportunity Zone business platform's job creation plans, and in so doing added a Florida component to the Fund's existing Georgia, and New Jersey Fund properties. Fund activities to date have included commercial, residential, and industrial project creation.

We expect to acquire additional properties in Jefferson County with an eye to continuing expansion of our commercial, industrial, and residential business development. You should recognize that Opportunity Zone Business development only makes sense where there is the possibility of 10-to-26-year successful investment through business creation leading to improving economic conditions of the opportunity zones in which we invest.

To be specific, our initial conceptual business platform will include site contracting, road building, and training facilities for equipment operators. We will follow with a logistics center planned to local distributions. Administrative office facilities will also employ staff to support business activities in business operations located within a geographic range from Orlando, Florida to Charleston, South Carolina to Newark, New Jersey. Beginning employee counts will range from 40 to 60 jobs. The median wage of our first stage staff should be \$57,000/year. Internally we plan to grow to 130 employees over the next three years. Job creation through

the logistics facilities should be in the range from 250 to 450 jobs depending on the requirements of the tenant business model.

One essential component of the growth that may be achieved rests in the availability of infrastructure needed to support the more intense land use that must accompany the creation jobs. This is especially true in opportunity zones where a lack of good paying jobs rests at the heart of Qualified Opportunity Zone designation. The Western portion of Jefferson County may benefit from residential expansion resulting from economic development in neighboring Leon County, but residential expansion alone will not lead to the job creation and tax base needed to dramatically improve economic conditions in Jefferson County. Simply becoming a bedroom community for Leon County will not be the driver that is needed to improve the lives of those currently living and trying to make a living in Jefferson County.

We urgently request that consideration be given to the extension of services effort that is underway in Jefferson County. We stand ready to assist in any way possible and hope to present plans for the first phase of our Fund's activities in the immediate future.

Dear Governor DeSantis,

On behalf of the North Florida Economic Development Partnership (NFEDP), I am pleased and excited to provide this Letter of Support for the Florida Jobs Growth Grant application being submitted by the City of Monticello. The application is seeking funding support for vital infrastructure that will enable the City to construct a master lift station and force main to extend and integrate its advanced wastewater treatment plant capacity to serve the I-10/Highway 59 interchange.

The project has joint support from both the City and Jefferson County. The potential job creation and CAPEX investment impacts for the entire interchange's four quadrants is extremely significant. A major commercial developer recently purchased 449 acres of the northwest quadrant which is in a Federal Qualified Opportunity Zone and multiple businesses have expressed great interest in locating on the site. The project forecasts 8-10 new businesses/companies, with up to 538 new, high quality wage jobs, generating a minimum of \$32 million in CAPEX. This is a tremendous investment opportunity for one of Florida's most economically constrained counties.

There has also been almost \$40 million dollars in funds invested in this interchange over the years including feasibility studies, engineering studies, Opportunity Zone investments, and construction improvements of existing facilities at the Interchange. Given the anticipated CAPEX and job projections, the prospective Return on Investment (ROI) will be extremely significant.
