The wastewater collection system is generally located within the core area of the Town and currently serves residential and business customers. The Collection system includes (4) four lift stations, connected gravity sewers, and force mains. Groundwater and local lakes are impacted by inflow and infiltration during heavy periods of rainfall (high groundwater). The Town's four (4) Lift Stations as a result operate above their design capacities exceeding the average daily flow placing the citizens of Eatonville at great risk for system failure. The high flows have caused the collection system to have disruptive surcharged. This has created concern for residents in Eatonville and the adjacent cities surrounding Eatonville including the water bodies within and adjacent to the Town. Eatonville is working strategically to regionalize independent water and wastewater system infrastructure to improve area-wide service and reliability in the Town; while maintaining the integrity of the environment and supporting economic growth, development and sustainability in Central Florida for the upcoming years with its Central location to Orlando. In order for the Town of Eatonville to keep existing business partners and attract new private investment, vital infrastructure is critical to creating good jobs and promoting full economic recovery. The proposed infrastructure project investment would provide immediate job opportunities, boost productivity, support the Town's business growth (through a mix of industries), provide a healthier environment, and improve opportunities for all of Eatonville's residents no matter their socio-economic background. Eatonville is poised to become one of Florida's growing communities but can't create economic diversification and viability without relying on well-functioning water and sewer systems. A number of studies find that the largest positive effects can occur in places where the quantity and quality of infrastructure lag (Town of Eatonville- 91.9% Black & Hispanic).

Eatonville borders the neighboring places of Fairview Shores, FL; Lockhart, FL; Maitland, FL; and Winter Park, FL and is one of few areas that still has undeveloped land within the Town to boost Economic Development. A new CRA Master Plan for the Town of Eatonville was approved on Feb. 16, 2016, incorporating the following: 1.Connectivity to Other Communities – to alleviate traffic and promote economic development; 2.High Performance Infrastructure – upgraded sewer, water and electric systems; 3.Attractive for Business and Economic Development Opportunities; 4.Embracing History, Culture and Education; and 5.Develop a Quality Sense of Place, Character & Image. Investment in Eatonville's infrastructure will boost employment as soon as it starts, and we anticipate 77 jobs generated as a result of the public infrastructure. The project's job creation impact will be extended between the public infrastructure phase as jobs will be created as a direct result of new business industries moving to the Town because of its location and available land.
