Pasco County and the Pasco County Sheriff's Office provided the land for the project and have also provided design and engineering services. This is a part of a multi-discipline project.

The funding requested in this grant will enhance this project by adding another discipline due to demand and enable it to better improve economic development in Florida as people travel both nationally and internationally to train at this site.



### **Answers to Questions**

#### 1A:

This Drone Center for Technological Training project is part of FIRST (Florida's Forensic Institute for Research, Security, and Tactics). The Drone Center for Technological Training is currently planned to be located inside of a hangar located near Central Boulevard in Land O'Lakes on property that belongs to Pasco County, and has been designated for use by the Pasco Sheriff's Office and is currently utilized for the grounds of FIRST.

The public infrastructure improvements include the building of parking lot/landing space for drones, classrooms and offices adjacent to the hangar, a maintenance area, and other infrastructure such as electric (to include generators for the use of battery charging stations), lighting, and IT costs related to WiFI internet availability/connectivity (to include transportable WiFI hotspots). These infrastructure items will allow the Drone Center for Technological Training to be fully operational.

#### 1E:

FIRST is part of a broad economic vision for Pasco County and the Tampa Bay area. This facility is home to one of the world's only forensic fields (only the 7<sup>th</sup> in the country and 8<sup>th</sup> in the world) and the first forensics field to have a direct connection to law enforcement. Through the expert training provided at this center related to forensics, tactics, leadership, cybersecurity, drones, and other disciplines, Pasco County will become a hub for training that currently does not exist anywhere in Florida (the closest forensic field is located in Tennessee).

This unique connection of experts in various fields and law enforcement will make this training a critical component of the military, civilian, and law enforcement community. With the constant schedule of ongoing trainings, we anticipate hotels, restaurants, shopping opportunities, and other types of economic development in this immediate area, along with an immediate boost to already existing hotel, restaurant, and retail establishments in Pasco County, FIRST is located just off of US 41 in Pasco County, providing a direct connection to Tampa, Tampa International Airport, I75, and the Suncoast Parkway. This area has also been identified by the Pasco County Economic Development Council as an area of targeted growth in the future of Pasco County. Through FIRST, trainings are already successful and are already putting "heads in beds" and boosting the local economy. This drone training will only enhance those capabilities and is in response to numerous companies and other entities who have expressed a desire to partner with us in Pasco County regarding drone technology and its use in public safety.

This project has the full support of the Pasco County Economic Development Council and, through an economic impact study conducted by the Pasco EDC, is expected to have an economic impact of greater than \$3 million per year which will continue to grow as additional trainings are created at the site.

#### 1F:

This project will achieve the goals of economic recovery, economic diversification, as well as economic enhancement of a Targeted Industry.

Economic recovery, as noted in the previous answer (1E) will come from the development surrounding this area as well as the "heads in beds" that will be required for training. The Pasco County Economic

Development Council has stated that this area is a critical area for future development in Pasco County. The EDC has also conservatively estimated this project will have greater than a \$3 million economic impact per year just through trainings provided, with a far greater economic impact expected through the development of hotels, shopping, restaurants, and other ancillary businesses that will locate to the area.

Economic diversification will also occur at this location, especially considering this facility is one of the few in the world to offer unique forensic services, and none of the other locations combine that field with other disciplines such as drone technology and cybersecurity. We expect economic diversification for Florida's workforce through this site as people from across the state, country, and world will be coming to FIRST to receive training.

In addition, this site will also serve as an economic enhancement of a Targeted Industry as this site and project will provide training in homeland defense, cybersecurity, and aviation/aerospace specifically related to the drone portion of this project. Jobs that will be created through this training program will include primarily NAICS industry codes 541990 (All other professional, scientific, and technical services), as well as 541370 (surveying and mapping services) and 541922 (commercial photography). These disciplines will receive expert training at FIRST and will be able to enhance their careers and law enforcement through these trainings.

#### 2B:

In tandem with other buildings on site, work has commenced. This will be completed within a year of receiving the funds. The desire is to complete this project as soon as possible due to the demand for drone research and training and its impact on public safety.

# FIRST - Drone Technology, Training, Tactics

Drone technology is growing exponentially. In the past, drones were most often associated with military operations. Today, drones are now used in a wide range of critical roles ranging from search and rescue, surveillance, traffic monitoring, weather monitoring, and firefighting. In order to support the expansion of this technology driven industry, continued education, training, research, and industry collaboration is required. Recognizing this critical set of requirements, Florida's Forensic Institute for Research, Security, and Tactics (FIRST) will develop a facility

that features a public/private partnership delivering information and skills focused on the use of drones in Public Safety. Our vision is to enhance Public Safety to better protect our communities.



The Federal Aviation Administration estimates that there are 2.5 million drones that regularly operate in U.S. skies. In 2020, that number could almost triple, with 7 million drones projected. The growth in drone use in Public Safety from 2014 to 2016 was over 518%. In 2016, there were at least 347 state and local police, sheriff, fire, and emergency units in the U.S. using drones. In 2018, the number increased to 910. This growth in the Public Safety drone market has spearheaded job opportunities, economic growth, and expanded Public Safety capabilities. FIRST's drone programs will become a gateway for development of jobs and technology in Florida. The programs' plan is to utilize simulation and hands-on instruction, development of advanced techniques and materials, and a partnership with technical experts to provide advanced training and research. This drone facility will create a learning environment through partnerships with public and private institutions leading to job creation and technical training for all of Florida.

The projected size of the drone industry by 2020 is \$13 billion and its value is expected to reach \$90 billion by 2025. Pasco County is one of the fastest growing areas in the State and features a unique blend of undeveloped, open spaces in close proximity to the amenities of a major metropolitan area, including 2 international airports. The public-private partnerships, research opportunities, and training programs made possible by FIRST offer the perfect opportunity to spark growth and entice businesses to start, move, or expand in Central Florida.

The breakdown of the 23 positions:

- 1 FIRST manager (\$70,000)
- 1 Director of Forensic Anthropology (\$130,000)
- 5 Program Administrators (1 for each tract) (\$45,000)
- 10 full-time instructors (\$66,000)
- 4 Administrative Assistants (\$45,000)
- 1 IT/Programmer (\$100,000)
- 1 Marketing/Recruiter (\$50,000)

As I mentioned these are conservative positions that will be filled in the first two years and don't include some things other, outside entities are doing like PHSC which are creating jobs through FIRST just because we don't have the information back from SACS yet.
