This request is for \$7,072,000, the cost of construction for this final phase of the project. These funds would be needed by spring, 2019 and would be fully expended by 2021. This represents approximately 15% of the total cost of the multi-phased project and 65% of the cost of Phase III of the project. The remaining costs for this phase of the project were provided by the City of Tallahassee through its Capital Budget process. These funds are available now.
