Title: Gadsden Technical Institute (GTI) Diesel Systems Technician 2 Training Program

Description: Through the BRE efforts of the Gadsden County Development Council, employers have defined the need for industry certified Diesel Technicians. These high tech, high wage jobs are crucial to the Gadsden targeted career cluster of transportation, distribution, and logistics. Gadsden Technical Institute will offer workforce training in Diesel Systems Technician 2: Medium and Heavy Duty Truck and Bus Technician. This program offers a sequence of courses that provides coherent and rigorous content aligned with challenging academic standards and relevant technical knowledge and skills needed to prepare for further education and careers in the Transportation, Distribution and Logistics career cluster; provides technical skill proficiency, and includes competency-based applied learning that contributes to the academic knowledge, higher-order reasoning and problem-solving skills, work attitudes, general employability skills, technical skills, and occupation-specific skills, and knowledge of all aspects of the Transportation, Distribution and Logistics career cluster.

The training includes five occupational completion points preparing students for jobs in diesel preventative maintenance, diesel heating & air systems, diesel steering & suspension systems, diesel drivetrain and diesel hydraulics.

As an addendum to the Florida Department of Education approved curriculum, participants will obtain an industry certification from the Daimler Get Ahead program, which offers the same courses that industry techs take to be Freightliner, Western Star and Fuso system certified. Participants who complete the full program are prepared for immediate employment.

B. Describe how this proposal supports programs at state colleges or state technical centers.

Gadsden Technical Institute (GTI) is a Career & Adult Education Technical Training institution located in Quincy, Florida in Gadsden County. The institute is accredited by the Council on Occupational Education (COE) and has received approval from COE to include the proposed workforce training of Diesel Systems Technician 2 in the Fall/Spring 2018-19 course offerings. GTI accepts Pell grant students, which increases participation of local citizens from a county with historically high poverty and unemployment rates. Through a partnership with Gadsden County Development Council (GCDC), CareerSource Capital Region and the Florida Department of Education, GTI is creating a registered Apprenticeship program to support this new workforce program and the "earn while you learn" approach embraced by the transportation, distribution and logistics industry. This new training program will further the mission of GTI, which is to recognize the worth and potential of each student; encourage academic and technical curiosity, innovation and creativity by integrating applied academic skills in all occupational areas; and, striving to instill the attitudes and skills necessary to produce motivated, self-sufficient individuals who are able to function effectively in an ever-changing, complex society.

C. Describe how this proposal provides participants transferable, sustainable workforce skills applicable to more than a single employer.

According to the Bureau of Labor Statistics (BLS), the employment or size of the Diesel Technician occupation in 2016 was 278,800. BLS projects that employment of diesel technicians will grow 10 percent from 2016 to 2026, faster than the average for all occupations. Job prospects should be best for those who have completed postsecondary training in diesel engine repair. According to industry analysts, the diesel tech unemployment rate is currently under 2% and there is a projected 12% increase in jobs, which equates to another 32,000 jobs or so over the next 7 years. Fifty percent of existing diesel technicians are age 45 or older. The demand for a diesel technician is very high now and will be even more so in a few short years. Gadsden County is home to a cluster of companies who employ diesel technicians: Waste Pro, Southway Crane, Tri-Eagle Sales, Cummins, Peterbilt, Four Star Freightliner, Capital Hydraulics, Coastal Forest Resources.

CareerSource Capital Region has identified job openings in the Big Bend region:

Average wage rates for diesel technician are Entry Level - \$14.80/hr, Mid Level - \$18.50-\$19.02/hr and Experienced - \$21.13/hr, which is greater than 125% of the average wage in Gadsden County.

A local employer, Four Star Freightliner, will augment this course with classroom computer-based instruction through the Daimler Get Ahead program and hands-on instruction in the diesel engine maintenance and repair bays at their new Gadsden County facility located at 270 Four Star Way, Midway, FL. The new facility provides student parking, a separate student entrance and restroom facilities. Additionally, GTI is creating a registered Apprenticeship for Diesel Technicians to support local employers who serve as Apprenticeship Sponsors and/or offer Apprenticeships. This tri-fold approach to training highly sought after diesel technicians will give program completers the broadest opportunity for immediate employment.

CareerSource Capital Region and CareerSource North Florida have joined forces with two south Georgia workforce boards, Worksource SW GA and Worksource South GA and formed the FL-GA Alliance to serve our primarily industrial base of manufacturers, warehousers and distributors who rely heavily on medium and heavy duty trucks to move their goods along shared transportation assets, such as I-10, I-75, US 90, US 27, US 19, US 231, CSX, G&W Railways. The Manufacturing, Construction, Transportation, and Logistics sector is one of four sectors that make up the most in-demand occupations and the economic development priorities of the region. The industry cluster in the FL-GA Alliance with the highest relative concentration is Wood/Paper with a location quotient of 2.94. This cluster employs 12,512 workers in the region with an average wage of \$42,458 and relies heavily on Freight Transportation (LQ 0.95) to move the wood/paper products that are produced. As such, Four Star Freightliner, Peterbilt, Cummins and Southway Crane have expanded facilities and workforce in Gadsden County in the past two years. In the case of Four Star Freightliner, the company has built a larger facility with two additional maintenance and repair bays directly on Interstate 10 and US 90. The project will retain 22 employees and add 10 direct jobs. Due to the economic impact, the project will create an additional 8 permanent jobs in the community for a total of 40 jobs, generate new revenues in excess of \$5.4 million annually and increase area payrolls by \$2.3 million annually. During the construction of the new Four Star facility and the related infrastructure, the county had an additional 36 jobs, over \$5.7 million in new revenues and a payroll impact of \$2.5 million.

The growing wood/paper cluster has attracted Project Azalea to Gadsden County-a new to Florida 65 acre greenfield development along US 27. This advanced manufacturer of wood products will make a \$3.3 million capital investment and employ 25 people at an average annual wage of \$40,000. The economic impact of this company is projected to be a total of 36 jobs, over \$5.5 million in new annual revenues and an annual payroll impact of \$1.6 million.

Due to the attraction of Project Azalea, the largest private sector employer in Gadsden County, Coastal Forest Resources, is expected to expand by a minimum of 25 jobs. The current economic impact of Coastal Forest Resources, is shown below. Coastal Forest Resources sees an average of 8 heavy duty trucks per hour of operation. Project Azalea will add 6 heavy duty trucks per day to that average.

The metrics used to measure the success of the training program will be 83.33% of participants obtaining a certificate or industry recognized credential each year, which is 10 out of 12 students per year and a job placement rate of 95%.

GTI currently offers Automotive Service Technology, Power Equipment Technologies, and Welding Technology programs. The addition of Diesel Systems will expand upon the Industrial offerings at the institute. The funds from this grant will provide the equipment necessary for students to master the required occupational completion points.

Both locations will offer textbook, computer-based and hands-on laboratory training.

A joint marketing effort between GTI, CareerSource Capital Region, Gadsden County Development Council and area employers will attract high school students seeking dual enrollment and adults that demonstrate interest and capacity to drive the program. State workforce development fund dollars and student tuition and fees will support the sustainability of the proposal. GTI will engage student and

instructor technician tools programs, such as at O'Reilly and Snap-On to help offset the sizable investment required in this industry. The grant budget is based on quotes received from these two programs.
