Dear Mr. Panuccio:

The Jobs for Veterans State Grant (JVSG) State Plan for Fiscal Years (FY) 2015-2019 and FY 2015 funding request from the Florida Department of Economic Opportunity has been reviewed and approved. FY 2015 funds, both those provided as part of this Continuing Resolution (CR) and as subject to availability, are available for obligation through December 31, 2015. States' use of funds must be consistent with JVSG spending plans for FY 2015. States will receive additional FY 2015 funds contingent on further CRs or an Appropriation Act for FY 2015.

All JVSG grantees should continue to obligate any FY 2014 funds before obligating any new FY 2015 funds. In the event a full FY 2015 appropriation is passed containing lower amounts than approved, VETS will mitigate funding shortages by first reducing grantee allocations by any FY 2014 funding amounts carried into the current fiscal year. If additional reductions have to be absorbed, the balance of the reduction will be shared among all grantees in direct proportion to their total FY 2015 funding requests.

Regional Administrators for Veterans' Employment and Training (RAVETs) will issue Notices of Obligation Authority (NOA) defining the amounts available for grantees to obligate through December 31, 2015 and expend through March 31, 2016.
