This is to request an extension of time participants in temporary disaster-related positions related to Hurricane Matthew. This request would pertain to participants performing duties of operating heavy equipment for cleanup, repair, renovation, and reconstruction of damaged public structures, facilities and land affected by Hurricane Matthew. The time extension requested is for an additional six months (1,040 hours). The time to train such workers is significant (up to two years) so that the extra time allowed under this project will make these workers more competitive for permanent employment. Additionally, there is not a pool of qualified individuals who also meet the grant eligibility requirements to replace these participants. The local workforce development board has a commitment to help all temporary workers obtain full-time, unsubsidized employment and will continue to work with the current worksite employer to look for opportunities to place these workers into regular positions.
