GRANT FUNDING AMOUNTS

b. The total amount of funds, \$\frac{10,117,000}{20,19644-10-55-5-12}\$, is allocated for the operation of the Disabled Veterans' Outreach Program (DVOP), the Local Veterans' Employment Representative (LVER) program, Transition Assistance Program (TAP) employment workshops, Special Initiatives, and Incentive Awards approved through incremental funding for Fiscal Year (FY) 2013 as indicated below:

- c. Availability of FY 2013 and subsequent years funds are subject to Congressional action on the U.S. Department of Labor (USDOL) appropriation. Allowable costs may be incurred up to the limit of the most recent Notice of Obligation Authority issued by the Regional Administrator for Veterans' Employment and Training (RAVET) to the grantee.
- d. United States Code of Federal Regulations requires that funds used to operate these programs are separately identified. Therefore, costs attributable to a specific program (DVOP, LVER or TAP) may be charged only to the funds available for each respective program. Except to correct mischarges, neither costs nor funds may be moved between programs or to any other program operated by the grantee without prior approval of a formal grant modification request. In the event the grantee incurs costs for either program in excess of the amount approved for that program, such excess will be borne by the grantee. Funds provided for this Fiscal Year must be obligated by December 31st of the year following the end of the current fiscal year and expended in accordance with the approved State Veterans' Program and Budget Plans.

GRANTEE COMPLIANCE

As a condition for the receipt of these funds, the grantee will provide—direct employment and training-related activities, and supportive services for qualified veterans, eligible persons, and transitioning service members and their families, as required under Title 38, Chapters 41 and 42, United States Code as amended, and related statutes.

As required by the Office of Management and Budget, recipients must have Dun and Bradstreet Data Universal Numbering System (DUNS) numbers and register within the Central Contractor Registration (CCR) database, under 2 CFR Subtitle A, Chapter 1, Subchapter B, Part 25 and comply with the regulatory posting requirements.

Your Jobs for Veterans' State Grant funding application for the grant period ending September 30, 2013, is approved subject to the terms found in this grant modification letter. Funds for Fiscal Year (FY) 2013 operations for the period October 1, 2012, through September 30, 2013, have been approved for obligation through December 31, 2013 in the amount of \$10,117,000, which includes all incremental funding previously provided this FY through Continuing Resolutions.

This amount includes \$5,068,000 for the operation of the Disabled Veterans' Outreach Program (DVOP), and \$5,027,000 for the operation of the Local Veterans' Employment Representative (LVER) Program, and \$22,000 has been authorized to conduct the number of Transition Assistance Program (TAP) Employment Workshops indicated in your plan. Use of one percent of funds for postage is included in the LVER funding amount above with no additional accounting or reporting requirements. Per your request, LVER funds include one-percent, \$114,000, of the total formula allocation earmarked for staff or office performance awards and incentives.

Total funding for your FY 2013 Jobs for Veterans State Grant is \$10,117,000. Mid-year adjustments and resource reallocations may occur depending upon spending patterns. The Regional Administrator for Veterans' Employment and Training for your region, will authorize the use of funds through the issuance of a Notice of Obligation Authority (NOA) on a quarterly basis. Since you may only drawdown funds from the Health and Human Services' Payment Management System (HHS/PMS) in thousands of dollars, the amounts provided will be rounded to the nearest thousand for DVOP and for LVER.
