

# Small Cities Community Development Block Grant FFY 2021-2022 Grant History Points



The following non-entitlement local governments are eligible to claim 100 Grant History Points for the Florida Small Cities Community Development Block Grant (CDBG) Program's FFY 2019 application cycle. Eligible communities are those which, as of July 21, 2022, have not had an open Commercial Revitalization, Neighborhood Revitalization (including Planning and Design) or Housing Rehabilitation subgrant during the past five years. Economic Development and Emergency Set-Aside subgrants do not count when determining Grant History Point eligibility, but American Recovery and Reinvestment Act projects do count when determining eligibility.
