Based on a recent Walton County water and sewer project and EDA's initial costs for the first section of roadway priced out at \$458 per linear foot. Allowing for inflation, \$465 per linear foot is used. Design, engineering and permit modification costs are estimated to be \$50,000.

    - G. Economic Recovery in the Northwest Florida Region: The Northwest Florida region is primarily made up of Rural counties and communities and

is still recovering from two major hurricanes and the impact from the Deepwater Horizon Oil Spill. The proposed Public Infrastructure project will significantly help support economic recovery and diversification through the attraction of new Florida targeted and regional industries committed to expanding and relocating to the Woodlawn Commerce Park along U.S. 331 in DeFuniak Springs Florida. The Commerce Park is suitably located to attract interested targeted businesses and industry due to its prime location along U.S. 331 and within 3 miles of Interstate 10. The area has an abundant level of training resources to support the training needs of those companies interested in investing in the future growth of Walton County. Industries targeted for the Commerce Park include: Aviation/Aerospace (Eglin AFB and Tyndall AFB are located in Walton County and neighboring Bay County). Approximately 350 plus defense contractors operate in the area. Another targeted industry sector is Manufacturing and the Commerce Park has already had success with the commitment of three manufacturing companies. Another targeted industry sector is Defense and Homeland Security (The Commerce Park is adjacent to Eglin AFB's Radar Facilities. Still another targeted industry sector is Life Sciences and Headquarters. The Commerce Park has interest from a small defense contractor who may establish their Corporate Headquarters in the Park due to the close proximity of the DeFuniak Springs Municipal Airport. The EDA, along with the Walton County Board of County Commissioners, The City of DeFuniak Spring, The City of Freeport and The City of Paxton (All who serve on the EDA Executive Board), help promote and market the Woodlawn Commerce Park on U.S. 331. Thus far the EDA has three committed targeted industries for the Commerce Park. The three firms will create an estimated 266 new full-time jobs in the Park. These positions will be provided through a new Drone manufacturer (20 jobs/NAICS 336411); A Housing Manufacturer (200 new, full-time jobs NAICS 321991); and a Truss Manufacturer (36 new full-time jobs NAICS 321214). All three firms will pay wages above the base wage for Walton County (\$18.11). Total Capital Investment for all three firms is estimated at \$12 million dollars.

<u>Public Infrastructure Improvements</u>: The Public Infrastructure Improvements are the critical elements to developing this expansion for the Park in addressing the needs of its current and future tenants. The Park is located along U.S. 331 which connects at the South end to U.S. 98 and to

Interstate 10 at the North end (approximately three miles from I-10). The Public Infrastructure Improvements will provide support to existing communities and their residents, existing businesses throughout the area and most-importantly to our existing families and the workforce that they represent. Creating new, diversified and targeted-industries that in turn help strengthen the local economic base of our communities, and create new, quality jobs for our residents, is the basis for requesting this grant.

  - The Owls Head Farms groundbreaking was successful and will include a farmers market along with 360 new homes.

  - o There will be no city elections this year due to no opposition.
