BIG BEND OFFICE EMPLOYMENT CENTER

- 1. A. The title of this project is the Big Bend Office Employment Center. The public infrastructure improvements being proposed include interchange improvements to Big Bend Rd at I-75, including turn lane additions, ramp extension, signalization and widening of Big Bend Rd.
- 1. E. As the primary job center for the Tampa Bay region, Hillsborough County has led Florida in job creation and in targeted industry business recruitment. Continuing to provide appropriate infrastructure to new development sites is the life blood of job creation and business attraction. Hillsborough County, as one of only a few urban counties in Florida, has to work harder and invest more to maintain its job generation competitive position relative to our national competitors.

The Big Bend Office Employment Center is located along the I-75 Job Corridor in the southwest quadrant of Interstate 75 and Big Bend Road. This strategically located office park contains 150 acres directly serving the fastest growing portion of Hillsborough County. This area which will only grow in importance as a job center is already contains 27.7% of the County population, and as a sub-market within Hillsborough County it already is bigger (in total population) than nearly 80% of the counties in Florida.

The proposed project is to provide the public roadway infrastructure necessary to advance this location as a primary competitive office park for the recruitment of new businesses and the expansion of existing companies. The improvements to Big Bend Road are critical to marketing the site and repurposing it for significant office development.

It is anticipated that the project will deliver more than 1.5 million square feet of office development fueling the needs of an anticipated 300,000 new jobs to be created in Hillsborough County over the next 25 years. This project alone will house approximately 8,000 targeted industry jobs.

Examples of this project are the two new USAA regional service centers built on the I-75 Job Corridor totaling 500,000 square feet of office and housing over 6,000 company employees. Hillsborough County is very effective and successful in attracting these type of companies but we need to continue to identify and provide infrastructure to open up and achieve the next strategic location for our next USAA-type, targeted-industry "wins".

Hillsborough County leads the state in the size of its financial services employment (with nearly 54,000 employees) and the percentage of financial services establishments (nearly six percent.) Ten percent of the nation's Fortune 50 and nine percent of the Fortune 100 companies' shared services operations are located here. As the fastest growing industry segment in the Tampa metro area, professional and business services have year-over-year employment gains of 3.38 percent and a total workforce of more than 207,000.

Not only do business and financial services firms choose Tampa for relocation or expansion, they have confirmed these decisions with further expansion and growth in the area. DTCC originally selected Tampa as the site of a redundant operations with 300 jobs, but now the site stands as a fully-integrated business operations unit with 530 employees with plans to add an additional 255. USAA's southeast home office location announced expansion plans with 1,400 jobs and the largest build-to-suit office project in Hillsborough County since 2001. Tampa-based HealthPlan Services picked our area for further expansion, planning to add to its existing 650 local employees with an additional 1,000 new jobs by 2018. These ongoing expansions cement Tampa and Hillsborough County's role as one of the nation's leading financial services and professional services centers.

The future economic enhancement of the financial and shared services industry is dependent on a ready supply of sites that can accommodate our next big relocation or expansion. The infrastructure proposed in this application is critical to unlock the full development potential of this 150-acre site. The development will result in 8,000 new jobs in the following NAICS code areas: Financial Services industry – NAICS 52, Management of Companies and Enterprises (Headquarter Operations) – NAICS 55, Professional, Scientific, and Technical Services – NAICS 54. The average wage of these jobs is estimated to be at least 150 percent of the County's average wage or \$74,661, which is 164 percent of the statewide average wage.

In addition to the 8,000 new direct jobs, the infrastructure will provide for 12,522 indirect and induced jobs; an additional \$307,735,681 in federal, state and local taxes on production and imports; and an overall earnings impact of \$1.35 billion to the economy. The project will result in more than \$300 million of private capital investment on construction of new office product and \$60 equipment and fixtures. The metrics for success for this project include the number of new jobs created, the average wage of those jobs, amount of new private capital investment made as a result of the improvements to public infrastructure, and the amount of new ad valorem revenue.
