The City of Plantation will, through its competitive procurement process, hire approximately 35 people for this project. The types of construction positions the City will hire will be design professionals. Currently Pine Island Park is host to the Plantation Athletic League's youth soccer program which serves approximately 1,200 recreational soccer players and 300 travel soccer participants per year. The park also serves as the playing fields for two adult soccer leagues as well as a multitude of local, regional and national soccer and lacrosse tournaments. In 2016, the athletic tournaments held at Pine Island Park hosted 34,346 participants and 51,519 spectators. These events were responsible for \$3.9 million in direct economic impact for the local economy.

Once the renovations of Pine Island Park are complete, an increase of several thousand participants and spectators is expected. With improved drainage, maintenance and turnaround time for field preparation will decrease which will allow more time for games and practices. The new, state-of-the-art facility will be an ideal location to serve the growing number of Plantation residents and host additional sporting and community events. With the current field conditions and drainage issues, play at the park is at its height during the Fall and Winter months and limited during our rainy season. With improved infrastructure support, the Parks and Recreation Department will be able to increase programming with 2 additional leagues and several more outdoor events (adult leagues, tournaments, outdoor festivals, etc.). This increased programming will have a direct positive impact on local hotels, restaurants, local attractions, businesses in our community and provide the City of Plantation and the local community with approximately \$2 million dollars from the increased number of leagues and events.

Pine Island Park Improvements

Page 2, 1e, provide a detailed explanation of how the public infrastructure improvements will connect to a broader economic development vision for the community and benefit additional current or future businesses.

The City of Plantation hosts 21 athletic events such as softball, lacrosse, flag football and soccer within the City's Parks and Recreation fields such as Pine Island Park. From these events hosted, 40,000 regional, national and international athletes participate and 115,000 spectators attend these events. The economic impact is \$8.6 million dollars to the local community. Therefore, once the renovations of Pine Island Park are complete, an increase of several thousand participants and spectators are expected. With improved drainage, maintenance and turnaround time for field preparation will decrease which will allow several more months for games and practices. With additional participants and events, the City and the surrounding restaurants, hotels and other attractions within the region will enjoy an increase of local community revenue impact of approximately \$2 million dollars.

The new, state-of-the-art facility will be an ideal location to serve the growing number of Plantation residents and host additional sporting and community events. With the current field conditions and drainage issues, play at the park is at its height during the Fall and Winter months and limited during our rainy season. With improved infrastructure support, the Parks and Recreation Department will be able to increase programming (adult leagues, tournaments, outdoor festivals, etc.). This increased programming will have a direct positive impact on local hotels, restaurants, local attractions, businesses in our community and provide the City of Plantation additional revenue from the increase number of events.

Along with South Florida's favorable year-round climate and central location in Broward County, Pine Island Park is easily accessible to the millions of residents in Miami-Dade, Palm Beach and Broward Counties. Out of state and International travelers can easily access the park through Ft. Lauderdale-Hollywood International Airport and Miami International Airport.

Pine Island Park consists of seven (7) multi-purpose natural grass fields, separate small concession/storage and restroom buildings and a modest parking lot located at the north end of Pine Island Park. This recreation facility is heavily used today for sanctioned soccer programs. There is a demand to accommodate additional sanctioned sports such as Lacrosse. The existing building and parking facilities struggle to meet existing needs and simply will not be capable of meeting planned future needs. Additionally, the existing grass turf fields suffer with poor drainage, resulting in flooded fields during even modest rain events, halting play and disrupting planned events.

Sec. 2-129. - Chief administrative officer.

The chief administrative officer is a senior executive of the city who serves under the general supervision and direction of the mayor. The Charter of Plantation provides that the mayor is the chief executive officer of the city. The chief administrative officer is the department head of the administration. The chief administrative officer does not occupy a municipal office; therefore, while the chief administrative officer has the general authority to supervise and direct other department heads in the exercise of their administrative functions and duties, the chief administrative officer does not possess or enjoy any sovereign law enforcement or life safety power of the city, and consequently, cannot direct department heads vested with such power with respect to whether or the manner in which they choose to exercise or not exercise such power. The chief administrative officer has the specific authority to: negotiate and execute contracts, liability indemnifications, licenses, easements, deeds, notes, and satisfactions or releases of liens or claims or interests in real property; make administer, and perform legal undertakings, including effecting or approving purchases or payments; and make decisions binding on the city during various types of negotiations or legal proceedings. The chief administrative officer shall additionally perform such other duties and functions and tasks as may be directed by the mayor.
