- Promote economic recovery in specific regions of the state, economic diversification or economic enhancement in a targeted industry. (View Florida's Targeted Industries here.)
- Are not for the exclusive benefit of any single company, corporation or business entity.
- Are for infrastructure that is owned by the public and is for public use or predominately benefits the public.

There is a critical linkage between transportation and economic vitality. The State of Florida is the seventh-largest export state in the U.S. with a total of \$82 billion in exported goods and services for 2016. Employment in Transportation and Material Moving Occupations accounts for 6% of total employment in Florida.

The proposed upgrades will not only bring in revenue from a targeted industry but it will also bring growth and economic recovery within the Town of Jay. Upgraded infrastructure will entice local development and the town has the potential for rapid growth because a large majority of the properties adjacent to the Town of Jay limits is undeveloped. Companies include the quality of a town's transportation system in their decision-making when relocating or expanding. Areas with congested or poorly maintained roads will see businesses relocated to areas with smoother, more efficient transportation systems. The proposed improvements will bring economic recovery to a community that is critical to the health of the Town of Jay's economy.
