- Are not for the exclusive benefit of any single company, corporation or business entity.
- Are for infrastructure that is owned by the public and is for public use or predominately benefits the public.

This improvement will ensure quality drinking water delivery to important core areas that are ripe for development and will give Palatka a needed advantage with companies looking to expand and/or relocate.

Palatka is currently comprised of households with low to moderate income levels, lower than average property values, higher than average unemployment rates and higher than average percentage of households living below the poverty line. The economic stimulus that this project could support would be immediately noticeable within this REDI community. The City is pro-actively financing a portion of this project and additional funding is being pursued from available outside sources, such as Cost Share Grants from the St Johns River Water Management District.

	\$1,000,000 in funding from SJRWMD has been obtained through Cost Share Grants. \$199,630 in funding from the Utility Line and Better Place Funds from the City of Palatka. The City is actively seeking the additional 7.6 million necessary to complete the						
	project areas. The City recognizes that certain limitations might apply to this funding source and the project can be broken into phases to conform with any monetary award.
