- Are for infrastructure that is owned by the public and is for public use or predominately benefits the public.

	Revitalization of East Ocean Blvd Corridor- The redevelopment strategy for this area is to expand the medical facilities that exist in close proximity from this corridor. The redesign of East Ocean Blvd has the potential to regenerate this entire area and create strong links with retail and restaurant uses along Ocean Boulevard and the Downtown as a whole. The development may then also be a catalyst for change in terms of economic regeneration within the East Ocean area of the City's CRA.					
	The City of Stuart plans to design a complete street for this corridor with protected bike lanes, see attached the rendering to better illustrate this concept.

Martin County FL is located at the epicenter of one of the state's fastest-growing clusters for life science enterprise and research. The revitalization of this corridor will provide opportunity for a variety of medical services as it relates to the life sciences industry.

This economic enhancement will increase opportunities for professional services by accommodating major employers within close proximity to the Downtown area of the City; create a complete streets environment for improved mobility for all users in the community; continue to build upon the transportation grid of the City; and lastly enhance and compliment the many redevelopment projects throughout the City of Stuart.

Martin Health System ranks among the top 10 percent of hospitals nationally and has been named six times to Thomson Reuters Top 100 Hospitals and also as one of the Top 50 Cardiovascular Hospitals. In 2015, professional services made up 9% of employment in Martin County. Most jobs identified within the medical services industry will range from \$23,000 to \$220,000.

The metrics used to measure a successful economic impact would be the number of jobs retained and created along this corridor. In addition, property values increase, increase in business permits due to the opening of new businesses along the corridor along with additional ad valorem to the City.
