Pursuant to section 288.101, F.S., the Florida Job Growth Grant Fund was created to promote economic opportunity by improving public infrastructure and enhancing workforce training. Eligible governmental entities that wish to access this grant fund must submit public infrastructure proposals that:

- Promote economic recovery in specific regions of the state, economic diversification or economic enhancement in a targeted industry. (View Florida's Targeted Industries here.)
- Are not for the exclusive benefit of any single company, corporation or business entity.
- Are for infrastructure that is owned by the public and is for public use or predominately benefits the public.

	This infrastructure improvements project is identified in the 2010 City of Stuart Community Redevelopment Plan. The redevelopment strategy for this area is to expand and reinforce the existing government center through accommodating the potential relocation of the existing School Board administration. The creation of additional major employment centers in this area of the City of Stuart has the potential to regenerate this entire area and create strong links businesses along Ocean Boulevard and the Downtown. By providing this infrastructure improvement should lead to significant revitalization due to the capital investment in this neighborhood. Not only is this project identified in the CRA Plan, it was also identified via the Asset Mapping Exercise as part of the DEO Competitive Florida Partnership grant process. This neighborhood was noted as an community asset and by providing investment in the area should result in economic opportunity per the Economic Development Strategy.

Revitalizing the East Stuart neighborhood, which includes the MLK Jr., Blvd. corridor, is central to the future of the economy and the quality of life. This economic enhancement will increase opportunities for professional services by accommodating major employers within close proximity to the Downtown area of the City; stimulate East Stuart through redevelopment opportunities within this planning area; create a complete streets environment for improved mobility for all users in the community; continue to build upon the transportation grid of the City; and lastly enhance and compliment the many redevelopment project throughout the City of Stuart.

As for job growth, this project will not only ignite a plethora of immediate construction type jobs for the re-design of the corridor, more importantly create opportunities for a variety of professional services: investment banking, legal services, municipal services, commercial and social services. Most jobs identified above will range from \$45,000 to \$150,000. In 2015, professional services made up 9% of employment in Martin County. There were gains in job creation among business and insurance services. As a result of a recent poll (Oct 2017) of the local industries along the MLK corridor, such as legal, county services, accounting, local community garden/cafe and the local school district offices many indicated they were either retaining or hiring in the next fiscal

Therefore, the metrics used to measure a successful economic impact would be the number of jobs retained and created along this corridor. In addition, property values increase, increase in business permits due to the opening of new businesses along the corridor along with additional ad valorem to the City.
