# FLORIDA DEPARTMENT OF ECONOMIC OPPORTUNITY FLORIDA JOB GROWTH GRANT FUND PUBLIC INFORMATION GRANT PROPOSAL

1A. Project Title - US 41 Linear Parking Project

Construction of 91 angled parking spaces along the south access road of US 41 between Bolander Terrace and Almonte Terrace, including landscaping and stormwater modifications. Parking spaces are strategically located to target established commercial development demonstrating a need for additional parking (See Attachment 2).

1E/F. Prior to its incorporation in 1959, the City of North Port was part of a larger General Development Corporation platted residential community known as "North Port Charlotte" which encompassed lands in both Sarasota and Charlotte Counties. The initial platting focused retail/commercial uses primarily in Charlotte County population center. That portion of the plat, that was to become the City of North Port, relied on existing retail, commercial uses found along the US-41 corridor.

From the time of its incorporation until the mid-1980's the City was basically a bedroom community that served as a workforce provider for the greater Sarasota-Manatee-Charlotte-Lee county region. As such early commercial/retail uses were limited to small 'mom and pop' operations along the US-41 corridor, and located either in a disjointed strip developments or individual parcels. Consequently, this growth pattern of linear, small parcel development along the US-41 corridor has led to development problems. These problems include but are not limited to:

- 1) Existing development with insufficient area for on-site parking, stormwater retention or landscaping
- 2) Undersized or lack of potable and waste water infrastructure
- 3) Inefficient access management and on-site traffic management

Starting in the mid-1980's until the present the City of North Port there has undertaken a concentrated effort to develop its economy through the diversification of its tax base from a predominately residential to a mixed base of residential, commercial, industrial and institutional land uses. Through the City's comprehensive planning effort and local, regional and state partnerships the City has balanced the ratio of land uses and has attained a basic level of infrastructure (e.g. schools, police and fire stations, water and sewer plants, roads, etc.); however, the City has an area of 104 square miles with a build out of only 28±%. The provision and retrofitting infrastructure is still a major need and driver of its economic health.

As indicated earlier the US-41 corridor in North Port has been traditionally its retail corridor where iconic and legacy small businesses have begun and thrived. In recent years the collection of small stores and offices have been joined by regional and national retailers, professional and office-

based businesses such as health care, finance, banking, and accounting, as well as personal and professional services support firms.

The Great Recession took its toll on the US-41 businesses and in fact, some of the older buildings that have been built since the 1950s to 1970s HAVE started to exhibit visible wear and tear. The maintenance and rehabilitation of these small retail and office locations along the US-41 corridor is very important. This is evidenced by the City's Economic Development Element which acknowledges small business revitalization and retention as vital components to the City's overall economic development strategy. Moreover, the City has allocated \$300,000 of City CDBG funds into a US 41 Façade Improvement Program. With North Port's economy gaining ground from the macroeconomic recovery and benefitting from the City's other economic development initiatives, the US-41 corridor is growing and keeping pace with the City's current 3.3% annual population growth rate. The City's efforts to retain and grow our small to medium retail and professional businesses is coming to fruition as shown in the in rapidly decreasing vacancy rate (83% in 2006 to 24% in 2017) in this sector (Source: Sarasota Economic Development Corporation, Real Estate Roundtable Group).

With the tremendous growth of the City, both in number of residents (178 in 1960 to 64,274 in 2016) and number of businesses (9 in 1959 to 3,785 in 2015), it is important to maintain viable locational options for start-up and small and medium businesses. For older venues parking has become a key factor in the success of small and medium businesses. The City's push to provide the linear parking amenity to supplement the existing parking spaces is an excellent example of how local government can support a growing local economy by ensuring its long-term viability.

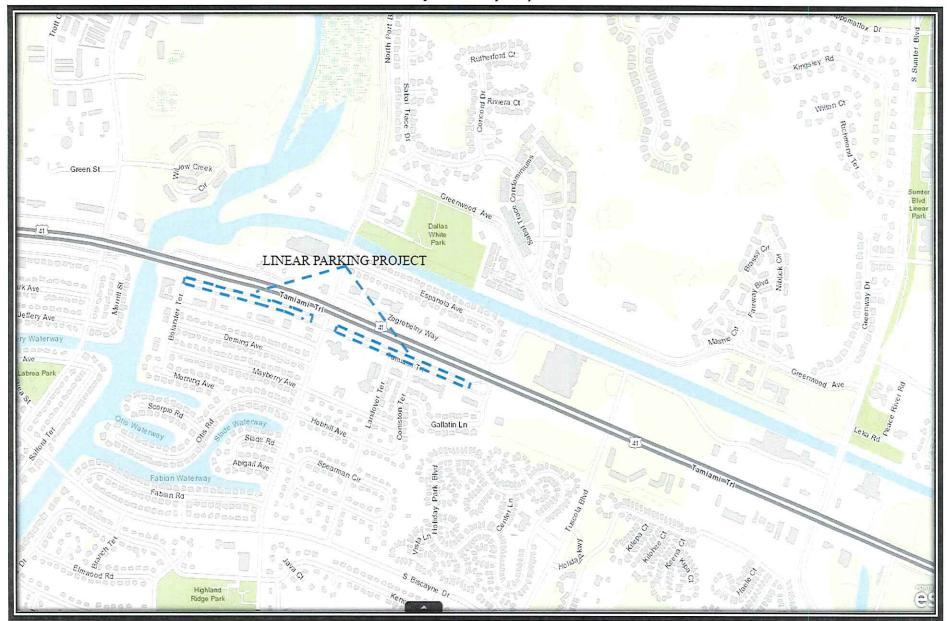
- 2B. Bidding phase of project initiated within one week of grant award. Construction contract is 120 calendar days.

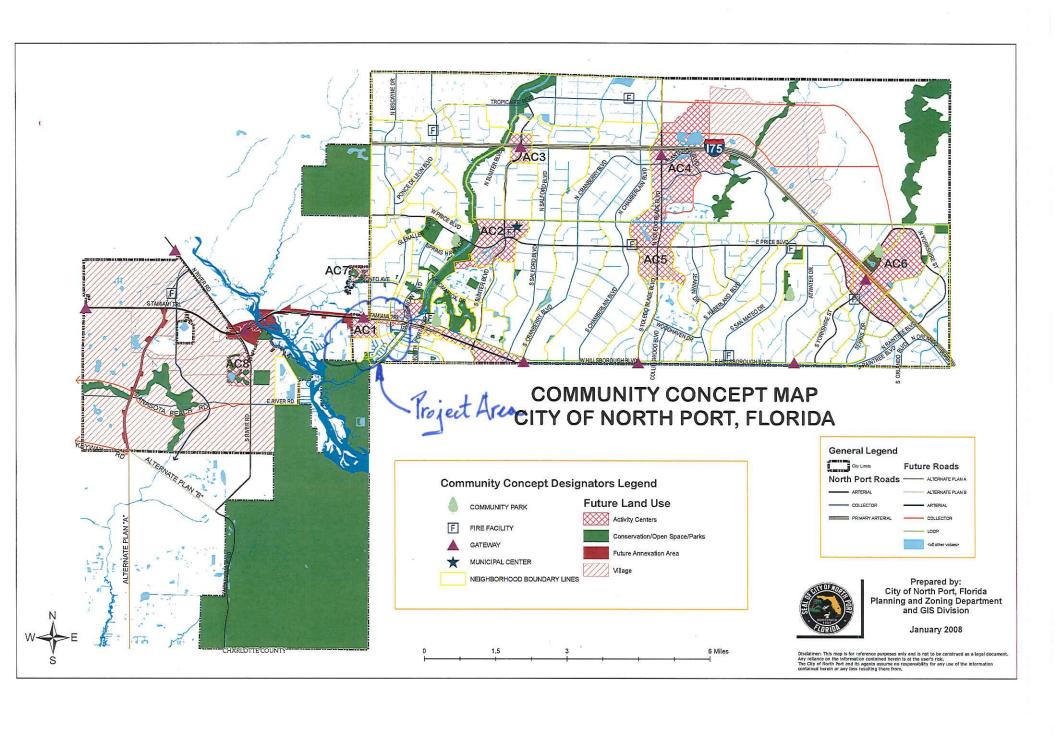

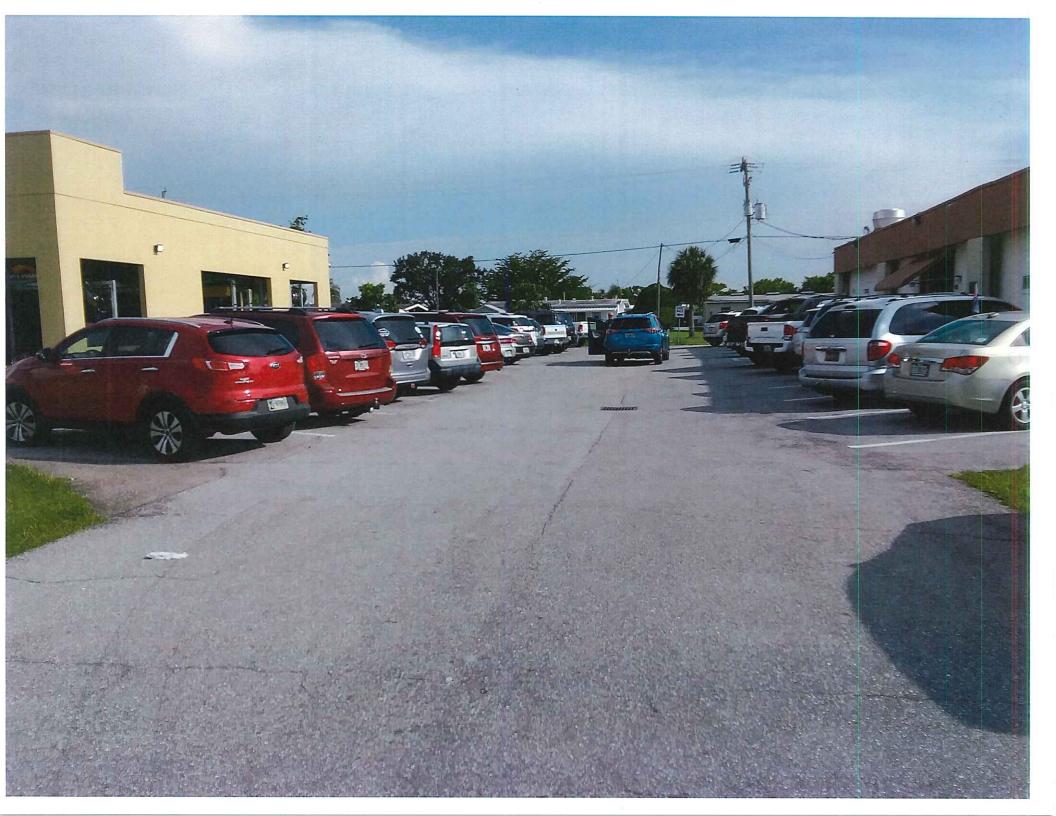

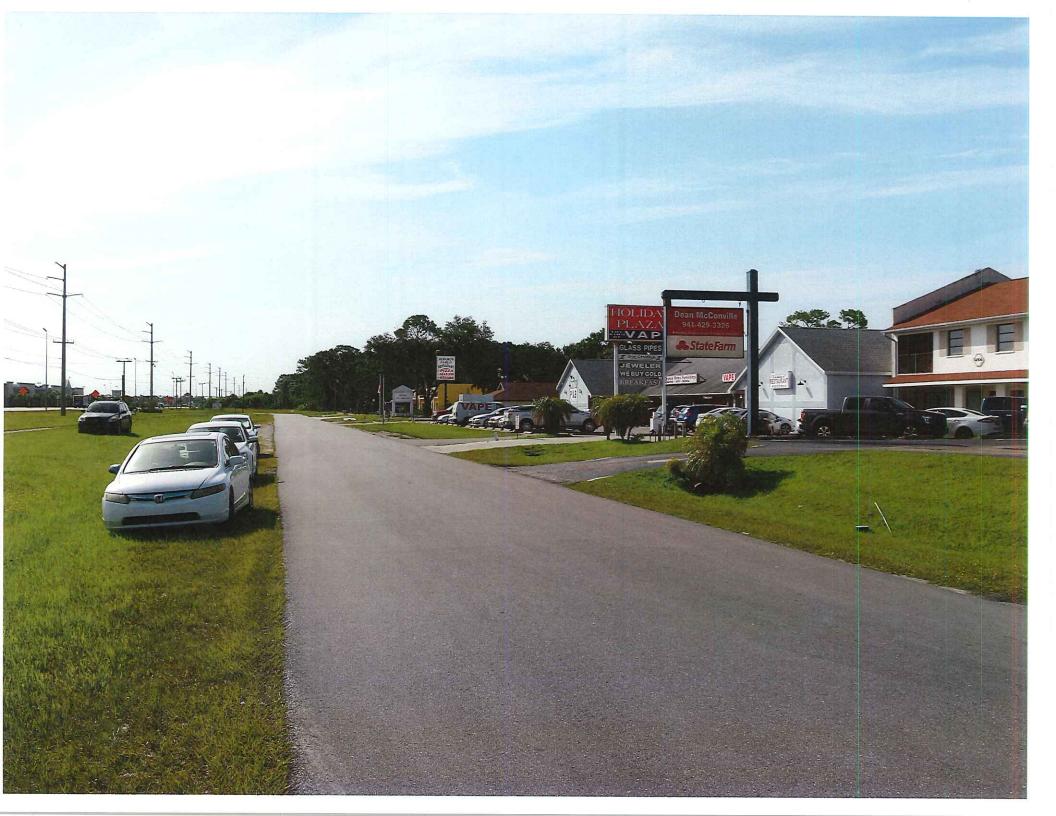

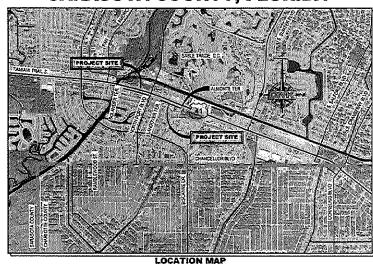

#### **Recommended Action**

Approve an application to the Florida Job Growth Grant Fund in an amount of \$424,400 for the US41 Linear Parking Project and authorize the City Manager to sign the application and accept funding if awarded.

#### **Background Information**

The US 41 Linear Parking Project was developed to address a deficiency of parking for established businesses along the southerly access roads of US41, between Almonte Terrace and Landover Terrace, and between North Port Boulevard and Bolander Terrace. The US41 Linear Parking Project has not progressed to the construction phase due to funding constraints. When the project plans were near completion, a meeting with abutting businesses was held, prompting changes to the proposed landscaping. The Engineer of Record's initial estimate of construction cost was revised to account for these minor changes and economic inflation. The revised construction estimated cost then caused a review of the project design to look for possible decreases in construction costs without decreases in the integrity of the project. The associated changes were made. A budget amendment was approved to account for the increase in estimated construction cost and the project construction was competitively bid through RFB No. 2017-03. Two bids were received, with the lowest responsive and qualified bid amount significantly higher than the budgeted amount and the other significantly higher than the low bid amount. Staff believes this grant fund application is a great opportunity to acquire the funding needed to construct this project.

Discussion ensued: (1) following a concern it was stated River Road is a County Road and does not qualify for Evacuation Route funding from the State and that with the Braves Stadium coming funding for River Road may be available for new economic development; (2) it was stated a Bill has passed allowing law enforcement to charge for drug trafficking of Fentanyl and a Bill is in process to make the Marchman Act mandatory; (3) it was noted that a Bill has been presented to amend the Baker Act regarding the handling of children under 18; (4) subsequent to a concern it was suggested the Commission write a letter to the Senators regarding the Certificate of Need, and it was noted that Health Policy Committee Chair Young would need to agree to hear the Bill and place it on the agenda; (5) following a concern it was stated that if conditions are met and the Developer completes their portion of River Road improvements in 2018, the State could potentially begin construction the end of 2018 or early 2019. There was no public comment.

Questions ensued: (1) following a concern it was stated there may be a hospital filing a Certificate of Need (CON) in February or March; (2) responding to an inquiry it was stated that United Healthcare Systems (UHS) could file an appeal but have not indicated plans to do so; (3) it was suggested City Manager Lear assist UHS with their appeal, if they choose to cite, to demonstrate the City's position in securing a hospital; (4) it was suggested to set an agenda item for further discussion and request a copy of the denial of the CON for review; (5) it was proposed that a Resolution to eliminate the CON process be sent to all Florida Senators. There was no public comment.

There was a consensus to create a Resolution to eliminate the Certificate of Need process as well as schedule a meeting with United Healthcare Systems in January.

#### 6. GENERAL BUSINESS:

A. 17-1538

Review the City's donation procedures of surplus items to 501(c) organizations.

City Manager Lear provided an overview of the item.

Discussion ensued: (1) it was stated that the intent of organizations completing registration on the City website is to obtain current contact information so that entities may be contacted as items are made available in the future; (2) it was suggested a list of available items be included on the City's website; (3) it was suggested prioritization of dispensed items should first benefit the City, followed by Sarasota County, then Charlotte and DeSoto Counties, and then all others.

There was a consensus that items donated should first benefit the City of North Port, followed by Sarasota County, then Charlotte and Desoto Counties, and then all other areas.

Discussion ensued: (1) following concerns it was stated the recipient has a duty to inspect items and that is coordinated through Finance, and if the item is not retrieved the next organization in line will be contacted; (2) concerns were stated that this method may

make donating public property less transparent and that the State is very specific regarding organizations eligible to receive donated items; (3) it was stated website registration pertains to low valued surplus items, and entities that register must meet the City's qualifications to participate and be awarded property; (4) it was suggested that language be added to the policy that items for donation have an original purchase price less than \$5,000, and that donated items are must not be resold for a one year period.

There was a consensus that donated items have an original purchase price of \$5,000 or less.

There was a consensus to clarify that in the advertisement the other reasonable use is in addition to the website.

There was a consensus that donated items cannot be sold for a period of one year.

A motion was made by Commissioner Hanks, seconded by Commissioner McDowell, to move forward with the City's donation procedures with surplus items to 501(c) organizations with the caveat of consensus items.

Discussion ensued: (1) it was suggested that some items of value should be sold to generate revenue for City projects; (2) it was stated the City Code should be revised to address maximizing all assets prior to donation and to specifically clarify which entities may receive donated items; (3) Commissioner Hanks and Mayor Carusone expressed opposition to selling low value items, and stated their reason for dissenting as great stewardship is demonstrated by donating items to agencies that assist members of the community. There was no public comment.

A motion was made by Commissioner McDowell, and seconded by Commissioner Luke, to amend the motion to add in the Policy there must be an attempt to sell the item first before donating. The motion carried by the following vote with Mayor Carusone and Commissioner Hanks dissenting for reasons stated.

City Manager Lear, Public Utilities Director Newkirk and Utilities Engineering Manager Acosta, provided an overview of the item.

Discussion ensued: (1) it was noted that this project was to be done in conjunction with the road project, however, in order to maintain funding this project must be completed by August 1, 2018; (2) following a concern, it was explained that this transmission line will bring reclaimed water to the Price Boulevard, Toledo Blade Road, Bobcat Trail and Panacea Boulevard areas; (3) it was explained that the additional transmission line is

needed to capture and distribute reclaimed water; (4) following a concern, it was stated the roadway plans have an allowance for the reclaimed water and the box culvert; (5) and Commissioner McDowell stated her concerns with construction, and that Springhaven may have to be re-dug. There was no public comment.

A motion was made by Commissioner Luke, and seconded by Commissioner Hanks to approve Consent Agenda item G, Contract No. 2018-02. The motion carried by the following vote with Commissioner McDowell dissenting for reasons stated:

Social Services will now be conducting the initial assessment; (2) it was stated failure of an agency to respond to a request within three days may result in loss of Federal funding; (3) it was noted that citizens can come to Social Services any day except Friday; (4) it was stated that Family Haven has two units in Social Services to assist the homeless in North Port and currently there are no other options; (5) subsequent to a concern, it was stated data reflecting the need for homeless housing will be collected by the agencies. There was no public comment.

A motion was made by Commissioner McDowell, seconded by Vice-Mayor Yates, to approve Memorandum of Agreement between the Suncoast Partnership to End Homelessness. The motion carried by the following vote:

Discussion ensued: (1) following a request for clarification City Attorney Slayton stated to Staff: [a] Commissioners are encouraged to utilize the Facebook pages provided by the City because of the way they are captured by the Vendor the City uses; [b] it is not just a matter of screen shotting because Facebook posts can change; [c] the Commission is encouraged to use the City's Facebook page for public records purposes; [d] if public record is created on a personal page Commissioner's are encouraged to screen shot the post; [e] the Attorney General and the Florida State Statutes don't give much guidance; [f] if answering or responding on Facebook where other Member's are tagged, could be an Open Meetings issue; [g] that anytime two are having a communication about an item that is before, is going to come before, or reasonably foreseeable to come before the Commission, those discussions must be made in open meetings that have been noticed and opened to the public; [h] to comment on something that is tagged, or shows on another Commissioner's page, could be an open meeting violations; [i] if you can see how each other is weighing in on positions, that could be an open meetings violation, even if not intentional, [j] from a legal perspective, utilize the City Facebook pages to communicate with constituents.

There was a consensus to direct City Manager Lear to draft letters for the Mayor's signature pertaining to the Commission's Legislative Priorities.
