Water Supply and fire protection is a critical Element for revitalization and Economic growth at this critical Interchange. In fact manufacturing Job losses have been documented at this interchange due to lack of water and sewer availability. Recently a Carrot processing facility moved to a Georgia interchange due to lack of infrastructure at the I-75/ CR 136 interchange. Water Supply and fire protection at this interchange will advance Economic activity within 3 counties (Suwannee, Columbia and Hamilton). The water supply system is critical to advancing economic activity such as Logistics and Distribution, Building Component Design and Manufacturing, retail and additional hotels.

The intersection of Interstate 75 and Hwy 136 is the exit to Live Oak, Florida and White Springs, Florida. This intersection is 36 miles south of the Florida-Georgia line. The uniqueness of this location is it's strong point. Exit 439 is 60 miles West of Jacksonville, 80 miles East of Tallahassee, 50 miles North of Gainesville and only 4 miles from one of the best North, South, East, West intersections in the country. Located just south of the famed Suwannee River and just west of the Stephen Foster Memorial State Park. This area of Florida is home to many outdoor activities to include: canoing, kayaking, diving, fishing, skiing, hunting, as well as one of the premier farming locations in the state and nation.

Every year over 110 million people come to Florida for tourism. Approximately 80 million of these tourists pass underneath the overpass at this intersection not knowing what they are missing. The reason for this is NO INFRASTRUCTURE.

The seventh item on the agenda was to approve Amendment #1 to Supplemental Agreement #15 with AECOM for design services for the West Apron Expansion at the Suwannee County Airport. Funded by FDOT. (Agreement No. 2014-44-15-01)

The eighth item on the agenda was to authorize submission of grant proposal(s) to Enterprise Florida and the Florida Department of Transportation for the Florida Job Growth Grant Fund.

This item was pulled for discussion.

The ninth item on the agenda was to authorize submitting an application for a Technical Assistance Grant, Bureau of Community Planning and Growth, FY 2017-18.

<u>The tenth item on the agenda</u> was to authorize constructing a new entry into the Falmouth Collection site utilizing Solid Waste Collection contingency.

Commissioner Richardson moved to approve Consent Agenda Items 2-7 and 9.

Commissioner Hale seconded, and the motion carried unanimously.

Chairman Gamble noted specific projects and that the supplement was to add them to the Capital Improvement Plan, as well as allowing the Chairman to sign any necessary documents.

Commissioner Sessions moved to authorize submission of grant proposal(s) to Enterprise Florida and the Florida Department of Transportation for the Florida Job Growth Grant Fund. Commissioner Hale seconded. Upon the recommendation of County Administrator Harris and County Attorney Prevatt, Commissioner Sessions amended his motion to include adding the projects to the Capital Improvement Plan and authorizing the chairman to sign any necessary documents. Commissioner Hale seconded, and the amended motion carried unanimously.

STAFF REPORTS:

The eleventh item on the agenda was Staff Reports.

Randy Harris, Public Works Director/County Administrator, discussed that 29th Road bids would be opened soon and discussed at the first August meeting. He also discussed a safety program and several other road projects, including work on Padlock Road and County Road 136. County Administrator Harris discussed the possibility of funding for the western portion of CR 136 within the Live Oak city limits. He also mentioned the need for funding to replace several bridges, including the one on 164th Street.

Commissioner Fleming asked about lighting improvements on US 129 at the Interstate I-10 interchange. County Administrator Harris replied that the work was underway.
