

## About the Community Contribution Tax Credit Program

The Community Contribution Tax Credit Program (CCTCP) provides a financial incentive (up to a 50% tax credit or sales tax refund) to encourage Florida businesses to make donations toward community development and housing projects for low-income persons. To be eligible to receive a tax credit or sales tax refund, a business must make an eligible donation to an approved sponsor who has received prior approval for a specific project. An organization and their project must be approved before it receives a donation. The donation must be used on the Sponsors approved project.

The following pages contain the names and addresses of the sponsors who have been approved for the state fiscal year starting on July 1, 2023, and ending on June 30, 2024. Please be advised that this approval does not imply any endorsement of the sponsor or the project by the Florida Department of Commerce. Prospective donors are recommended to perform due diligence research prior to making donations for the approved project.

## CCTCP Sponsors

Sponsors are listed in numerical order of their project numbers (based on the numbering system for counties found on the last page of this fact sheet). Each sponsor/project has a four digit and a one to three letter number.

For example, the first sponsor/project listed on the first page is the Alachua Habitat for Humanity, which is located in Gainesville and Alachua County. Their project number is CC-0103-E. The first two digits (01) reflect the county (Alachua), the next two digits (03) reflect the city (Gainesville); and the letter (E) reflects the fifth project in Gainesville.
