Ms. Richey most recently served as deputy superintendent overseeing the division of School Quality, Instruction, and Performance at the Virginia Department of Education. In this role, she oversaw state policies and all agency functions relating to student assessment, accountability, accreditation, federal programs, special education, special

student populations, teacher licensure and education, school support and improvement, standards development, and career and technical education and adult education.

Previously, Ms. Richey served as acting assistant secretary and principal deputy assistant secretary in the Office for Civil Rights at the US Department of Education (2018-2021). From 2017-2018, she served as acting assistant secretary and deputy assistant secretary in the Office of Special Education and Rehabilitative Services at the U.S. Department of Education. Prior to joining the Department, Richey served as the managing director of federal advocacy and public policy at the National School Boards Association. Formerly, she served as the general counsel for the Oklahoma State Department of Education (OSDE), where she represented OSDE, the State Board of Education, and the state superintendent of public instruction.

Prior to her work at OSDE, Richey served as the general counsel and associate director of the Oklahoma Council on Law Enforcement Education and Training, a postsecondary education certification and training agency. From 2004 to 2009, she served at the U.S. Department of Education as the counselor to the assistant secretary in the Office for Civil Rights (2004-2009). During that same time, Richey also served as acting chief of staff in the Office of Legislation and Congressional Affairs. Richey is a native of Corpus Christi, Texas, and holds a bachelor's degree in education from Southern Nazarene University and a juris doctorate degree from the University of Oklahoma.
