**SUBJECT:** Revised Program Year (PY) 2017-2018 Monitoring Review Schedule

Due to ongoing recovery efforts in a number of local workforce development areas (LWDA) as a result of Hurricane Irma, the Department of Economic Opportunity's Bureau of One-Stop and Program Support has revised the monitoring review schedule for program Year 2017-18 (see revised schedule attached).

The monitoring review schedule has been adjusted to move some of the panhandle and neighboring gulf coast regions scheduled for the 2018 calendar year up to the 2017 calendar year, and move some of the most affected central and southern regions scheduled for the 2017 calendar year to the 2018 calendar year. This will lessen the impact on LWDA staff in the most affected areas and allow more time for recovery efforts before monitoring takes place.

Please note that not all LWDAs are affected by the schedule changes. The LWDAs with schedule changes are highlighted in yellow. Please review the alternate dates for your respective LWDA and contact us by October 12, 2017 if the dates present a conflict.
