ANNUAL REPORT

Section 288.714(3), Florida Statutes, direct the Department of Economic Opportunity (DEO) to provide the Governor, the President of the Senate, and the Speaker of the House a report on the performance of the Black Business Loan Program (BBLP).

The seven (7) Black Business Investment Corporations (BBIC's) that administered the BBLP in Fiscal Year 2012-2013 submitted quarterly reports to DEO. The following annual report is a summary of the information submitted by the BBIC's for the time period of July 1, 2012 through June 30, 2013.

PROGRAM OVERVIEW

In 2007, the Florida Legislature created the Florida Black Business Investment Act, which established the Black Business Loan Program within the Office of Tourism, Trade, and Economic Development (OTTED). During the 2011 Legislative Session, the BBLP was transferred to DEO as part of government re-organization.

Annually, DEO may certify program administrators, known as Black Business Investment Corporations (BBIC's) that submit certification application packages. The certified BBIC's use program funds to make loans, loan guarantees, and investments in black business enterprises that cannot obtain capital through conventional lending institutions but can otherwise compete successfully in the private sector.

Certified BBIC's are authorized to use the program funds in any of the following forms:

- a) Purchases of stock, preferred or common, voting or nonvoting; however, no more than 40 percent of the funds may be used for direct investments in black business enterprises;
- b) Loans or loan guarantees, with or without recourse, in either a subordinated or priority position; or
- c) Technical support to black business enterprises, not exceed nine percent of the funds received, and direct administrative costs, not to exceed twelve percent of the funds.

All loans, loan guarantees, and investments, and any related income must be used to carry out the public purpose of the Florida Black Business Investment Act, which is to develop black business enterprises.

PROGRAM APPROPRIATION

For Fiscal Year 2012-2013, the Florida Legislature appropriated \$2,225,000.00 for the Black Business Loan Program. Pursuant to section 288.7102, F.S., DEO shall distribute an equal amount of the appropriation among all certified recipients.

CERTIFIED PROGRAM RECIPIENTS

Based on the review of applications for certification, DEO certified the following BBIC's as eligible recipients of Fiscal Year 2012-2013 program funds:

PROGRAM RESULTS

During Fiscal Year 2012-2013, the BBIC's used program funds to make loans, loan guarantees, and provide lines of credit to forty (40) black business enterprises across the state. The businesses receiving loans and loan guarantees performed the following types of business activities:

- accounting/financial services;
- construction/contracting;
- educational technology;
- fitness center;
- hair salons;
- lawn care;
- management training;
- property management;
- restaurants.

- auto repair;
- distribution;
- environmental engineering;
- funeral services;
- healthcare;
- legal services;
- pharmaceutical sales;
- retail sales; and

Combined, the BBIC's provided 40 black business enterprises with 64 forms of financial assistance as reflected below. The program funds used in these transactions totaled over \$1.46 million. In addition to these program funds, businesses received \$670,681.05 from other sources of funding.

Combined, the BBIC's reported the following number of jobs that were created and/or retained by the businesses receiving financial assistance:

In addition to providing financial assistance to businesses, the BBIC's provide technical assistance to their clients. They reported over 125 instances of providing technical assistance to black business owners during the 2012-2013 fiscal year. Methods of providing technical assistance included consultation by phone or in person, business seminars, round table discussions, and workshops. Areas of assistance included cash flow management, credit counseling, marketing, personal issues and obtaining financing. The BBIC's forums for technical assistance were also open, and served in many instances, non-black-owned businesses.

The BBIC's conducted outreach activities to raise awareness of the program. They participated in over 93 outreach activities including attending community events, working with local bank branches, participating with local service organizations such as the chambers of commerce and economic development councils, and presenting the program at seminars, conferences, and workshops. In addition, the BBIC's referred business owners to other lenders and funding sources during the year.

- Appendix B provides a listing of the businesses that received loans or guarantees. The listing is sorted by the BBIC providing the funds and then by the transaction date.
