ORDER

This matter comes before me for final Department Order.

Having fully considered the Special Deputy's Recommended Order and the record of the case and in the absence of any exceptions to the Recommended Order, I adopt the Findings of Fact and Conclusions of Law as set forth therein. A copy of the Recommended Order is attached and incorporated in this Final Order.

In consideration thereof, it is ORDERED that the determinations dated February 11, 2014, are AFFIRMED.

JUDICIAL REVIEW

Any request for judicial review must be initiated within 30 days of the date the Order was filed. Judicial review is commenced by filing one copy of a *Notice of Appeal* with the DEPARTMENT OF ECONOMIC OPPORTUNITY at the address shown at the top of this Order and a second copy, with filing fees prescribed by law, with the appropriate District Court of Appeal. It is the responsibility of the party appealing to the Court to prepare a transcript of the record. If no court reporter was at the hearing, the transcript must be prepared from a copy of the Special Deputy's hearing recording, which may be requested from the Office of Appeals.

Si en la audiencia no se encontraba ningún estenógrafo registrado en los tribunales, la transcripción debe ser preparada de una copia de la grabación de la audiencia del Delegado Especial [*Special Deputy*], la cual puede ser solicitada de la Oficina de Apelaciones.

RECOMMENDED ORDER OF SPECIAL DEPUTY

TO: Magnus Hines

This matter comes before the undersigned Special Deputy pursuant to the Petitioner's protest of the Respondent's determinations dated December 11, 2013.

After due notice to the parties, a telephone hearing was held on March 19, 2014. The Petitioner, represented by its president, appeared and testified. The Respondent was represented by a Department of Revenue Tax Specialist I. A Tax Specialist I testified as a witness.

The record of the case, including the recording of the hearing and any exhibits submitted in evidence, is herewith transmitted. Proposed Findings of Fact and Conclusions of Law were not received.

ISSUE: Whether the Petitioner is entitled to waiver of penalty and interest for delinquent reports, pursuant to §443.141(1), Florida Statutes; Rule 73B-10.028(4), Florida Administrative Code.

Findings of Fact:

1. The Petitioner is a corporation which was formerly operated from its Texas headquarter location. On December 1, 2011, the Petitioner's current president purchased the business and moved the business headquarter to New Jersey.
2. The Petitioner has employees in a number of states, including Florida. When the business was sold the current president relied upon the previous owner to notify the various states of the mailing address change. The previous owner did not notify Florida or the other states of the address change.
3. The current owner also relied upon the previous owner and an accountant located in Texas to file federal payroll tax returns and the quarterly state unemployment tax returns, including the reemployment assistance tax returns for Florida. The previous owner and his accounting staff did not prepare and file those tax returns.

4. When the Florida Department of Revenue did not receive the reemployment assistance tax returns for the second, third, and fourth quarters 2012, delinquency notices were mailed to the Petitioner. However, since the Petitioner had not notified the Department of Revenue of the address change the notices were mailed to the Texas address and were not received by the new owner.
5. The new owner eventually became aware that the previous owner had not filed the Petitioner's tax reports during 2012. The Petitioner has been working with the federal government to pay the delinquent taxes and has been contacting the individual states to file delinquent tax reports. The Petitioner filed the delinquent Florida reemployment assistance tax reports for the second, third, and fourth quarters 2012 on November 4, 2013.
6. On November 5, 2013, the Petitioner submitted a written request to the Florida Department of Revenue for waiver of late filing penalties. The reason for the waiver request, as stated in the letter, was that an in-house accountant was responsible for filing the tax reports and that the in-house accountant had not filed the tax reports.
7. By determinations dated December 11, 2013, the Department of Revenue denied the Petitioner's request for waiver of penalty. The Petitioner filed a timely protest by letter on December 19, 2013.

Conclusions of Law:

8. Rule 73B-10.025(1), Florida Administrative Code, provides:
 - (b) Each quarterly report must:
 1. Be filed with the Department of Revenue by the last day of the month following the calendar quarter to which the report applies, except for reports filed by electronic means, which are to be filed as provided in Rule 73B-10.023, F.A.C. However, an employer reporting for the first time is authorized 15 consecutive calendar days from the notification of liability to submit reports for previous calendar quarters without incurring penalty charges; and
 2. Be filed for each calendar quarter during which the employer was liable, even if no contributions are payable. If there was no employment during the calendar quarter to which the report applies, the report must be completed to so reflect.
9. Section 443.141, Florida Statutes provides:
 - (1) Past Due Contributions and Reimbursements; Delinquent, Erroneous, Incomplete, or Insufficient Reports.-
 - (a) Interest. Contributions or reimbursements unpaid on the date due shall bear interest at the rate of 1 percent per month from and after that date until payment plus accrued interest is received by the tax collection service provider, unless the service provider finds that the employing unit has good reason for failure to pay the contributions or reimbursements when due. Interest collected under this subsection must be paid into the Special Employment Security Administration Trust Fund.
 - (b) Penalty for delinquent reports.
 1. An employing unit that fails to file any report required by the Department of Economic Opportunity or its tax collection service provider, in accordance with rules for administering this chapter, shall pay to the tax collection service provider for each delinquent report the sum of \$25 for each 30 days or fraction thereof that the employing unit is delinquent, unless the agency or its service provider, whichever required the report, finds that the employing unit has good reason for failure to file the report. The department or its service provider may assess penalties only through the date of the issuance of the final assessment notice. However, additional penalties accrue if the delinquent report is subsequently filed.
10. Rule 73B-10.028, Florida Administrative Code, provides:
 - (4) Waiver of Penalty and Interest. Pursuant to Sections 443.1316 and 443.141(1), F.S., the

Department is authorized to waive imposition of interest or penalty when the employer files a written request for waiver establishing that imposition of interest or penalty would be inequitable, however, the Department will not consider a request for waiver of penalty until the employer has filed all reports due for the five years immediately preceding the request for waiver. Examples of inequity include situations where the delinquency was caused by one of the following factors:

- (a) The required report was addressed or delivered to the wrong state or federal agency.
- (b) Death or serious illness of the person responsible for the preparation and filing of the report.
- (c) Destruction of the employer's business records by fire or other casualty.
- (d) Unscheduled and unavoidable computer down time.
- (e) Erroneous information provided by the Agency or Department; failure of the Department to furnish proper forms upon a timely request; or inability of the employer to obtain an interview with a representative of the Department. In each case, a diligent attempt to obtain the necessary information or forms must have been made by the employer in sufficient time that prompt action by the Department would have allowed the reports to be filed timely.

11. Even though the current owner relied upon the former in-house accountant or the former company owner to file the quarterly tax reports with Florida, it was the Petitioner's responsibility to ensure that the tax reports were filed and that they were filed on time. It has not been shown that the Petitioner was prevented from filing the tax reports by some extraordinary means such as demonstrated in Rule 73B-10.028, Florida Administrative Code. It has not been shown that imposition of penalty was inequitable. Thus, the Department of Revenue is not authorized to waive penalty and interest.

Recommendation: It is recommended that the determinations dated December 11, 2013, be AFFIRMED.


