O R D E R

This matter comes before me for final Department Order.

Subsequent to this appeal being docketed, the Petitioner filed another appeal under Docket Number 0025 1286 09-02. Since the subsequent appeal will resolve the issues at hand, it is hereby ORDERED that this protest is dismissed.

JUDICIAL REVIEW

Any request for judicial review must be initiated within 30 days of the date the Order was filed. Judicial review is commenced by filing one copy of a *Notice of Appeal* with the DEPARTMENT OF ECONOMIC OPPORTUNITY at the address shown at the top of this *Order* and a second copy, with filing fees prescribed by law, with the appropriate District Court of Appeal. It is the responsibility of the party appealing to the Court to prepare a transcript of the record. If no court reporter was at the hearing, the transcript must be prepared from a copy of the Special Deputy's hearing recording, which may be requested from the Office of Appeals.
